If you post or comment on this page, or send us direct messages, we may collect and process information about you ("**personal data**") on our systems, but only where this is necessary the purposes described below. In such cases, Gedeon Richter is responsible for the processing of your personal data as it decides why and how it is processed, acting as the "**controller**". In this Privacy Notice, "**we**" or "**us**" refers to Gedeon Richter UK Limited.

Specific personal data to be collected

As necessary for the purposes described below, we may collect the following specific personal data about you:

- Your basic profile information (e.g. name, sex, country)
- Personal data contained in your posts and comments on this page or directed to us
- Personal data contained in messages sent to us

Specific purposes for which we require your personal data

This information will be used by us for the following specific purposes:

- To manage and answer any questions, requests, or complaints you raise
- To inform our communications activities, including the content and target audience of the posts from our social media accounts
- We ask you not to do so, but if you use Facebook to alert us to medicinal side effects, product quality complaints or other regulated situations, we may log your query and contact you for additional information. We may also be required to disclose your personal data to regulatory authorities

Please note that personal data may also be used by us for a number of other standard purposes. We will not process your personal data if we do not have a proper justification foreseen in the law for that purpose, and this means we will only process your personal data on one or more of the following bases:

- The processing is necessary to pursue the legitimate purposes described above, where these do not unduly affect your interests or fundamental rights and freedoms
- The processing is necessary to comply with our legal or regulatory obligations
- The processing relates to personal data which has been manifestly made public by you
- We have obtained your explicit consent

Your rights

If we process your personal data, you are entitled to ask for a copy of it and to correct it. You can also ask for it to be erased or to restrict its processing, or to have some or all of it transferred to another organisation. You may also have the right to withdraw your consent to the processing of your personal data. These rights may be limited in some situations, such as where there is a legal requirement to process your personal data.

Duration of storage

We will only store the above personal data for as long as necessary to comply with our legal and regulatory obligations and to fulfill the purposes described above.

Gedeon Richter will not be responsible for use of your posts or interactions outside of these intended purposes by you or any third party. No part of our responses to you may be published and should not be disseminated to third parties out of context of the original enquiry.
